# EXTENDED 5-YEAR WARRANTY

on qualifying drop door and DishDrawer™ dishwashers.

Fisher & Paykel Appliances is offering a five-year limited manufacturer's warranty with the purchase of Qualifying Dishwashers. Information on the instant rebate forms part of these Terms and Conditions. Participation in this promotion is deemed as acceptance of these Terms and Conditions.
